Administrative Medicine Active status is granted to you as a licensee who may advise organizations, both public and private, on healthcare matters; authorize and deny financial payments for care; organize and direct research programs; review care provided for quality; and other similar duties that do not require direct patient care. **A physician with an Administrative Medicine license may not examine, care for or treat patients.** This license must be renewed by the expiration date above.

Licensees must notify the Oregon Medical Board within 30 days of changing a practice, home or mailing address. Address changes may be made on the Board's website at www.oregon.gov/OMB; clicking Online Services on the home page will allow you to log in and make updates. If you need assistance, please contact the Licensing Call Center at 971-673-2700.

A licensee with Administrative Medicine Active status must reactivate to Active status prior to beginning a practice of direct patient care in Oregon. The reactivation process takes approximately 4-6 weeks.
